Monetary Developments ^(*)

Money supply M_0 decreased from AED 65.3 billion at the end of March 2014 to AED 65.2 billion at the end of April of the same year (-0.2%), while M_1 increased from AED 412.0 billion to AED 426.3 billion (3.5%), M_2 decreased from AED 1,124.3 billion to AED 1,123.7 billion (-0.1%), and M_3 increased from AED 1,280.2 billion to AED 1,293.0 billion (1.0%). During the first four months of 2014, there has been an increase of 2.0% in M_0 , 12.3% in M_1 , 6.3% in M_2 and 6.0% in M_3 .

The Money Multiplier

The money multiplier indicates by how much the money supply will grow following an increase of 1 billion Dirhams in the monetary base (currency in circulation + commercial banks' reserves at the Central Bank + certificates of deposit).

The money multiplier of M_1 remained unchanged at 1.4 at the end of April 2014 i.e., at the same level of the previous month, whereas the multiplier of M_2 increased from 4.0 at the end of March to 4.1 at the end of April and that of M_3 increased from 4.5 to 4.7. The increase in the money multipliers of M_2 and M_3 was mainly due to a decrease in Banks' Current Accounts at CBUAE (Net) by AED 8.7 billion and a decrease in Certificates of Deposit (Net of Lending) by AED 1.8 billion.
